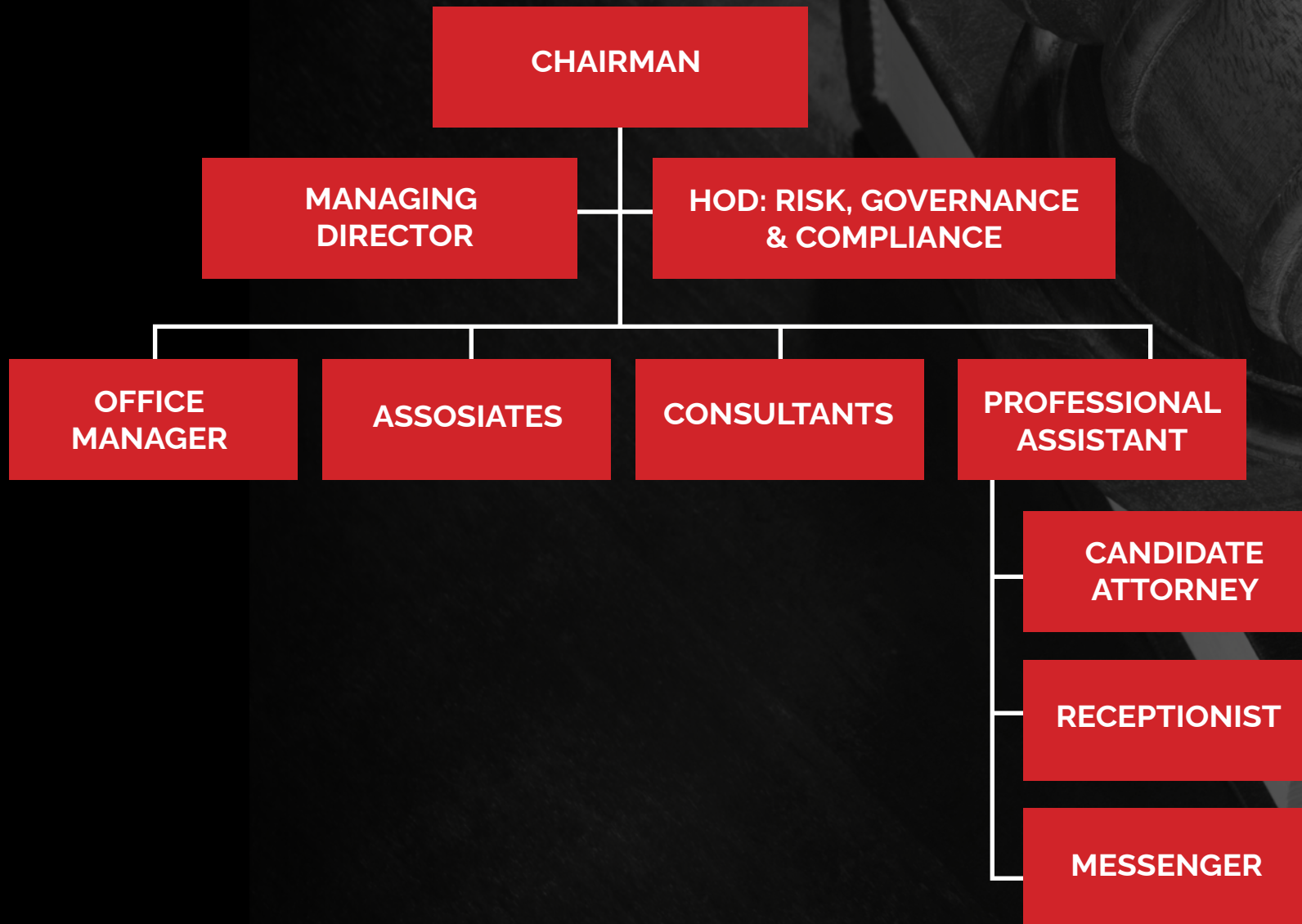


DAPHNEY MAVHUSHA:
